3. Batteries, accumulators and button cells containing more than 0.004% lead, shall be marked with the chemical symbol for the metal concerned: Pb.

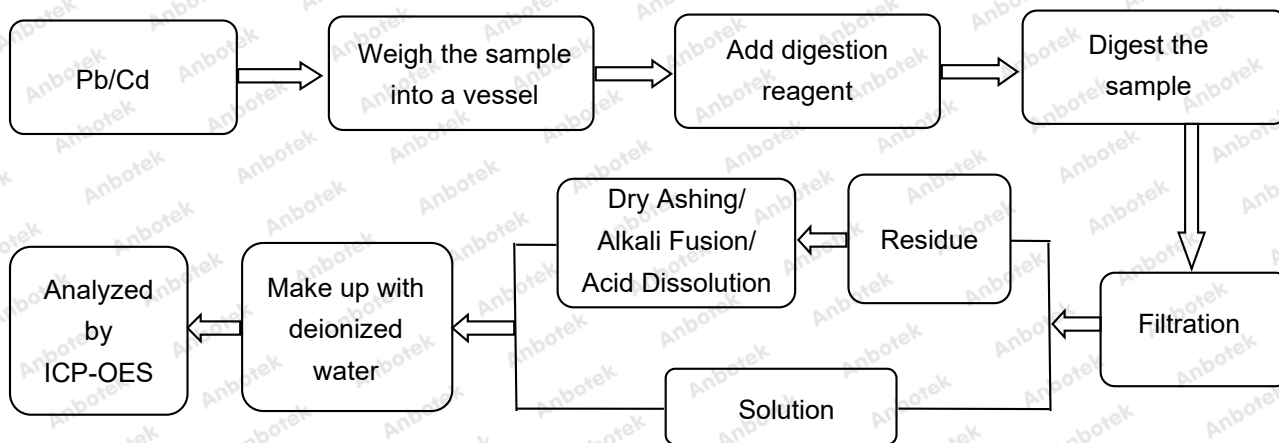

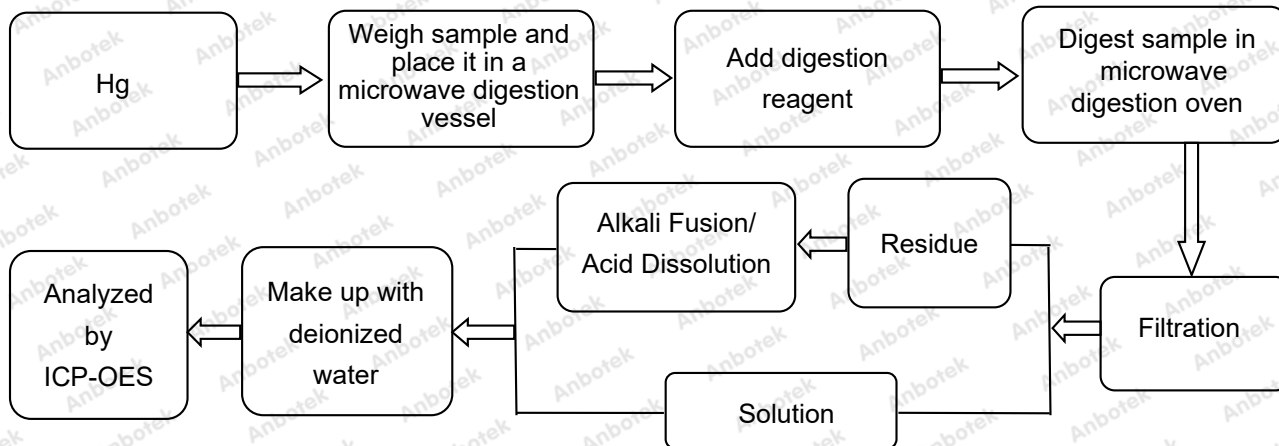

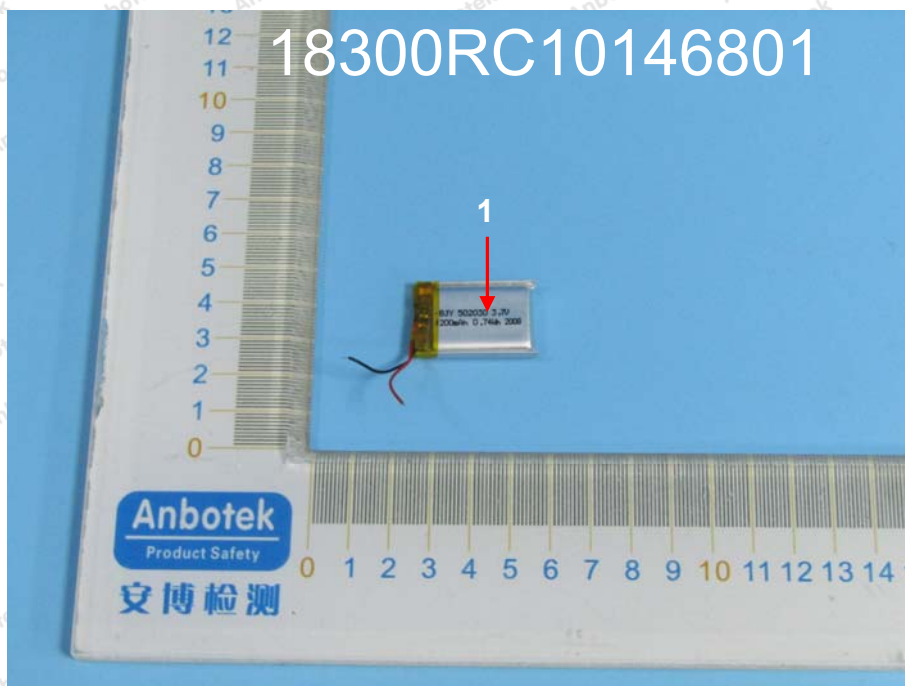
