



- 2)Then the sample is separated from the IC card. And put this IC card gradually close to the reading machine, to see how far the IC card could be read. Mark the distance
- 3)Compare A and B



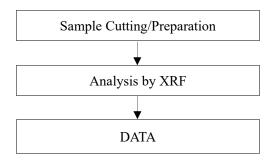






### **Test Flow Chart of XRF**
